Fairfax County, VA (pop. 1.2 million) has an exciting, new opportunity for an experienced and innovative technology leader to direct our nationally recognized technology program, serving as the county's Chief Information Officer (CIO). The CIO shapes the strategic direction for technology services and digital transformation, and provides leadership, direction, oversight, and guidance for the administration, planning, budgeting, operations, and activities of the Department of Information Technology (DIT). With a workforce of over 350 staff, supervising a team of IT program directors, managers, architects and commercial services, DIT provides all aspects of technology services across all technology disciplines. DIT funding levels are \$155M over several operating budgets, and over \$75M in the total IT Investment budget plan. Those budgets fuel new technology and digital strategic priorities enterprise-wide, county agencies and new mandates, as well as \$6.5 million in grants supporting regional CIO programs. The CIO is also responsible for IT architecture enabling on-line digital service to the public in multiple venues, overseeing the development and support of ERP, WEB, CRM, and GIS platforms, and is the steward of county IT assets and access supervising the county IT/ Cyber Security office.



THE COMMUNITY AND REGION

Fairfax County is a highly desirable place to live, work, and play, offering a dynamic mix of suburban tranquility and metropolitan access. Located just minutes from Washington, D.C., the county combines a rich historical heritage with a vibrant, forward-thinking economy. 




THE ORGANIZATION

Governed by a 10-member Board of Supervisors, Fairfax County government consistently achieves high praise for fiscal stability, quality service and technological sophistication. With over \$5.4 billion projected for FY25 in general fund revenues, Fairfax County maintains an exceptional Triple-A bond rating from three leading rating agencies – Moody's Investor Services, Standard and Poor's, and Fitch Investor Service.

Fairfax County operates under an urban county executive form of government. The Board of Supervisors is responsible for the legislative and administrative affairs of the County. The Board of Supervisors consists of nine members elected by district, plus a chairman elected at large. The Board elects the vice chairman annually from among its members at its first meeting in January. Board members are elected for four-year terms. The Board of Supervisors appoints a County Executive who is the administrative head of the county government and oversees the day-to-day administration on behalf of the Board.







THE POSITION

The director/CIO serves as a member of the county's Senior Management Team, is a key advisor to the executive team, and works with and supports county agencies' opportunities for adoption of technology supporting their operations, Board of Supervisors' goals for innovation and digitization, and the county's strategic priorities and associated initiatives and to further the development of strategies for IT, associated delivery models, programs, investment strategies and business transformation opportunities to align with the county's mission, vision and values. The CIO also collaborates with the citizen Information Technology Policy Advisory Committee (ITPAC) on technology practices and trends.

Fairfax County is also a leader in the national capital region for enabling intergovernmental interoperability. The CIO also represents Fairfax in regional and state activities.

Fairfax County has been named in the top five of similar sized governments for technology achievements over the past 25 years and has received multiple important awards. Fairfax also enjoys a national reputation for digital excellence in governance, technology foundation, WEB, court technology innovation, cyber security and the 'Government in the Palm of Your Hands' initiative, to name a few. This is an exciting opportunity to join Fairfax as the County moves forward with new strategic priorities.

The ideal candidate will be a collaborative, transformational leader and have a strong strategic and business mind-set with a proven record of building a high performing, customer-focused IT environment and efficient IT operations that align with, drive county goals, and deliver results. The CIO will foster a public service environment that leverages the creativity and technical expertise of a team of skilled and knowledgeable staff, build on a culture of excellence and successes, and create new priorities, models, and opportunities.



REQUIRED QUALIFICATIONS

- Knowledge of the principles and practices of process innovation, and reengineering/redesign; Knowledge of the principles and practices of organization and management.
- Demonstrated knowledge of the principles and practices of project management, contract management, and vendor relationships.
- Ability to foster and maintain successful customer relationships and provide quality service;
- Ability to analyze complex technical data and draw sound conclusions.

- Ability to present ideas effectively, both orally and in writing.
